

Setting The house is located on busy Rt. 110 in a mostly residential area. Behind 77 Acton Rd. the ground slopes down to a woods, which are behind all the house on this side of the road toward the cemetery & Chelmsford Center. A wide driveway leads from the road up beside the left side of the house. A swampy ravine lies between the driveway and #85 Acton Rd. next door.

This 2½ story tenement dwelling located at 77 Acton Road has many roof lines, although its primary roof ridge goes front to rear. A turret is located on the front right side of it. Sometime during the 1976 – 1995 period the attie was used for a business office. However, the present owners have converted it, the 3rd floor, to a bedroom area.

A paved driveway goes from the street (Acton Rd.) to the rear of the building beside the left side of the residence. A small swampy ravine is to the left of the driveway.

HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners occupants played within the community.

In Nov. 1887 Mr. Louis A. Young had "just let the contract to Eugene Prescott for the erection of two neat and substantial cottages" and foundations were being put in for both this house at 77 Acton Rd. and also next door at 85 Acton Rd. However. on Sept. 28th, 1888 Mr. Louis Young was "building a second dwelling house on Acton street, near the one erected by him last year." Unlike the residence next door at 85 Acton Rd built the previous year, this house has been a two family rental from its beginning until 1999.

In 1891 "George Wright, the new blacksmith, has hired a tenement of L. A. Young" on Acton St. and in Sept. 1914 Philip Donahoe "has removed to the Ellinwood house in Acton street." He was the local railroad flagman in Chelmsford Center for many years, and he and his family were still living at 77 Acton Rd. in 1922, when Loren Ellinwood sold the property. Mr. Ellinwood and his family were residents of Lowell in 1902 when he purchased this house, but the family soon moved to West Chelmsford and did not reside at 77 Acton Rd. In Sept. 1921 the tenants of the house applied to the water commissioners to have water installed. The water mains had recently been laid down the street making it possible to do so. However, in a letter to Mr. Ellinwood the water department wrote that "this, of course, means quite a little outlay. In the first place the service from the main to the cellar wall must be paid for by you. Then the piping in the house, faucets, etc. This, however, would not be the end of our trouble for the dry well that is there now is not adequate to take care of the waste water under the present conditions, and with running water they certainly would use two or three times as much as they do now, so if the water is put in it would be necessary to at once provide a much larger dry well.....for a rough estimate we would say it must cost around \$200." Whether or not Mr. Ellinwood agreed to spend the money to have running water put in at this time is not known, but 6 months he sold the property, so perhaps he didn't. He sold it to water commissioners Herbert Ellis, who had written the letter to him, and his partner Edward Robbins. The running water was surely installed at this point, if Mr. Ellinwood hadn't!

Throughout most of its history, this house has been a two family dwelling, and often the owner has been one of the residents. However, since 1999 the current owners have been the only ones living in the house.

Nov. 4, 1887 – Mr. Louis F. Young, the recent purchaser of the T.W. Marshall estate on High street, has made improvements upon the buildings. The addition of bay windows and verandas, together with a partial remodeling of the interior, has nearly transformed the original house into a new one. Mr. Young has just let the contract to Eugene Prescott for the erection of two neat and substantial houses on the Acton road a few rods south of its intersection with the road to Robin's hill. It is intimated that this may be the beginning of Mr. Young's enterprise in this line and locality.

Workmen are busy putting in the new foundations for Mr. Young's houses on the Acton road.

Sept. 28, 1888 - Mr. Louis Young is building a second dwelling house on Acton street, near the one erected by him, last year.

Apr. 17. 1891 – George Wright, the new blacksmith, has hired a tenement of L.A. Young on the same street.

Apr. 27, 1900 – One of the "Young" houses, so-called, on Acton street was disposed of Saturday afternoon at foreclosure sale. It was knocked off to the mortgagee by Auctioneer Wooley of Groton for \$2100.

Sept. 11, 1914 – Phillip Donahoe, who has lived in the Railroad block in Littleton street for a number of years, has removed to the Ellinwood house in Acton Street.

March 15, 1916 - Little Josephine Donohoe is ill at the home of her father, Philip Donahoe in Acton street with an attack of tonsillitis.
