

## **ARCHITECTURAL DESCRIPTION:**

Describe architectural features. Evaluate the characteristics of this building in terms of other buildings within the community.

The two-story building has a stone foundation, walls clad in wood clapboard with wood trim, and a slightly-pitched side gable roof. The building features narrow wood corner boards. Fenestration throughout the building includes six-pane fixed casement and six-over-six double-hung windows. The primary (south) façade includes two ribbons of six-pane windows on the first story. The set on the west bay are flanked by double-hung windows; the east bay has a double-hung window on the west side and a pedestrian door on the east side. Four single, six-pane casement windows are on the second story. The west wall includes a pedestrian door near the center of the first story.

The building was included in the NRHP nomination of the Old Chelmsford Garrison House Complex Historic District in 1973. The building retains sufficient historic integrity to be listed in the NRHP.

### HISTORICAL NARRATIVE

Discuss the history of the building. Explain its associations with local (or state) history. Include uses of the building, and the role(s) the owners/occupants played within the community.

The building was constructed on site ca. 1950 by then owners Sarah and John McCormick, who were farmers with approximately 500-800 chickens. The coop was remodeled in 1966 for use as the McCormick Craft Center for educational tours of the Garrison House property. Tour participants churn butter, craft quilt squares, make soap, and dip candles in the building in order to learn more about life during the Colonial era.
