9. Historical significance (include explanation of themes checked above)

In 1800 there was a school house located on the lot east of the present lot, facing Old Westford Rd. It was on the lot on the west side of Isaiah Spaulding's house at 263 Old Westford Rd. (#33). In 1838, the town voted to divide school district No. 7; however, in 1870 it was voted to unite districts #7 & #10 and to build a new 2 story house 32 x 46 feet. The old District No. 7

building was probably closed at this time.

Six years later at the annual town meeting held March 6, 1876 Benjamin J. Spaulding, who lived at 219 Westford St. (#31), joined neighbors in requesting that a new building be erected. At the following annual meeting, held March 5, 1877 it was voted to "purchase $\frac{1}{2}$ acre of land adjoining the present school house lot in that part of the town formerly known as School district no. 7 and build a school house thereon and that the town shall raise and appropriate the sum not exceeding \$1500 for the pure ase of the land and erection of the house." The land was bought one week later for \$50.

On March 27, 1899 the town authorized the selectmen to sell "the lot and buildings thereon in former school district No. 7." This was done one

year later, when Castherine M. Savage purchased it for \$1. Commence of the Commence of th

"In the year 1800 the Town supported twelve schools at an expense of six hundred dollars. They were located as follows:

At the middle of the Town, now District 1. At the North School house, now District 2. Near Ebenezer Parker's, South Chelmsford, now District 3. At Mill Row, now District 4. At Squadron by Capt. Benj. Fletcher's, now District 5. At Concord River Neck, now District 6. At Schoolhouse by Simon Stevens's, now District 7. At Newfield, now North Chelmsford, District 8. At Grate Neck, now Lowell. At Samuel Marshall's, also Lowell, corner Parker and Powell Streets. At Schoolhouse by Joseph Adams' and at schoolhouse by Benj. Chamberlain's.

One of the last two named was, undoubtedly, in Carlisle, where the schoolhouse now stands, north of Great Brook, and the other in Lowell."

"Schools No. 7 near West, now closed) and No. 5 (Byam's) were discontinued, and at a subsequent meeting schools No. 2 (North Row) and No. 4 (South Row) were placed on the same list. These schools, after remaining out in the cold a short time only, were kindly restored to the fold...

1874-5

Whether consolidation of portions of former districts No. 2 and No. 7 cannot be advantageously effected, making the number of schools one less thereby adding to the length and efficiency of all, is worthy of the careful consideration of the present School Committee and of all friends of education in town. This might require an annual appropriation of a small sum of money, to be expended under the direction of the committee, for the purpose of carrying children remote from school.."

A certain tract of land, with the building thereon situate in the Westerly part of said a Chelmsford, and on the Northerly side of the road leading from West Chelmsford, (so-called) to Chelmsford Centre, containing 1/2 acre, be the same more or less, and thus bounded and described:

Beginning at the Southeast corner of the premises at a stone bound at said road at land formerly of Isaiah Spaulding;

Thence Northerly 146 feet and 8 inches to a stone boundery,;

Thence Westerly 148 1/2 feet to a stone boundary;

Thence Southerly 146 feet and 8 inches to a stone boundary at said road;

Thence Easterly on said road 148 1/2 feet to the point of beginning, intending by this deed to convey all land now fenced in, and formerly occupied as a lot for Schoolhouse in former District No. 7.

Being the same lot of land conveyed to the Town of Chelmsford by deed of Isaiah Spaulding dated March 15 AD 1877, and recorded with Middlesex North District of Deeds, Book 123, Page 34 Selectmen, being duly authorized by vote of the inhabitants of Chelmsford at a legally called meeting for that purpose, held March 27, AD 1899, to sell and convey the above described property, a certified copy of said vote, being attached hereto"
